

**RESOLUTION SETTING FEES AND  
LIMITING NUMBER OF LICENSES AVAILABLE  
FOR MARIHUANA ESTABLISHMENTS**

**CITY OF IRON RIVER, MICHIGAN**

At a regular meeting of the Iron River City Council held at the Iron River City Hall on November 10, 2021 at 4:30 p.m.

PRESENT: Rodney Dood, Anthony Clements, Ronjo Leonoff and Mayor Dennis Powell.

ABSENT: Benjamin Garcia

The following Preamble and Resolution was offered by Rodney Dood and supported by Anthony Clements:

**RECITALS:**

The City of Iron River has amended its Marihuana Ordinance to authorize recreational marihuana establishments within the City under the Michigan Regulation and Taxation of Marihuana Act, Initiated Law 1 of 2018; and

The City's Marihuana Ordinance at Section 8(1) requires the City Council to establish, by resolution, the initial application fee and renewal fee for each type of establishment; and

The City's Marihuana Ordinance at Section 8(2) requires the City Council to establish, by resolution, the number of licenses for each type of marihuana establishment that will be issued in each respective zoning district in the City; and

The City Council has reviewed the application process, the enforcement burden, and the administrative burden on City Police and City Staff in determining the initial application fee and renewal fee; and

The City Council has heard public comment, has considered the proposed zoning restrictions on marihuana establishments, and has considered the safety and general welfare of the City's residents;

**IT IS RESOLVED:**

1. The initial application fee for each marihuana establishment in the City of Iron River, regardless of type, is \$5,000. The fee is non-refundable.
2. The renewal fee for each marihuana establishment in the City of Iron River, regardless of type, is \$5,000. The fee is non-refundable.

3. Subject to all terms of the City of Iron River Marihuana Ordinance and the City of Iron River Zoning Ordinance, the maximum number of licenses that may be issued for each type of marihuana establishment in each zoning district is established as follows:
